ORDER

As per paper read(1),sanction has been accorded to disburse PG/PhD contingency grants @Rs.40000/ for PG programmes and @Rs.100000/ for PhD programmes . As per University Order read (2) the maximum amount that can be paid to PG and PhD students towards TA/DA as part of research work were fixed as Rs.5000&Rs 8000 respectively,amending Clause 6-Students Welfare and Benefit Schemes-TA/DA of Academic Handbook. As per paper read (3) PG/PhD students were permitted to meet the printing and binding charges of thesis from the contingency grant for research work by limiting the charges to Rs.4000/ for PG and Rs.5000/ for PhD students.

Resolutions were moved in the 139 th Academic Council to enhance thesis printing charges for PG students to Rs. 7000/- and that for PhD students to Rs. 10000/- and also to to enhance the TA/DA as part of research works to Rs. 10,000/- for PG students and Rs. 20,000/- for Ph.D. students .The Council has approved the enhancement permitting re allocation of funds between subheads within the total budget outlay of contingency grant for research works.

In consonance with the decision of the 139th meeting of Academic Council, the following orders are issued.

- 1. The PG/PhD students are permitted to meet the printing and binding charges of thesis upto Rs.7000/ for PG students and Rs.10000/ for PhD students from the contingency grant for research work within the allocated budget.
- 2. The maximum amount permissible towards TA/DA as part of research works will be Rs.10000/ for PG students and Rs.20000/ for PhD students subject to the condition that the Advisory Committee will decide on the re allocation of funds between subheads within the limits of sanctioned budget allocation of Contingency Grant for research works for each programme.
- 3. Necessary amendments will be effected in the Academic Handbook of KAU.
