- 2. **Earnest Money Deposit:** An EMD (1% of the amount quoted subject to minimum of Rs.1500/-) should be remitted by separate DD drawn in favour of the Comptroller, KAU, Vellanikkara, Pin 680 656.
- 3. The tender should be accompanied by an Agreement in Kerala stamp paper worth Rs. 200/- (Rupees two hundred only) in the format that can be downloaded from the website www.kau.in/tenders
- 4. The sealed cover containing the tender documents should be super scribed as "Tender for supply of Steel Almirahs for setting up of record room at Directorate of Research, KAU." The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.
- 5. The successful tenderer/bidder should execute an agreement in Kerala Stamp paper worth Rs.200/- (Rupees two hundred only) and furnish a security deposit of 5% of cost of the rate quoted in the form of term deposit/bank guarantee/ demand draft drawn in favour of the Comptroller, KAU, Vellanikkara payable at the State bank of India, KAU Vellanikkara Campus (Branch code.70670), when directed from this office.
- 6. The prices quoted should be inclusive of all taxes, duties, cesses, transportation charges and also connected expenses if any. The rate will be valid upto one year from the date of acceptance.
- 7. Items should be delivered and placed safely at the second floor (roof top) of KAU C. Achuthamenon Memorial Academic & Research Management Block, Vellanikkara.
- 8. The Director, Directorate of Research, KAU, Vellanikkara has the right to accept or reject any or all of the offers without assigning any reason.
- 9. The successful tenderer shall initiate the work/supply the item within one week of award and should finish the supply within one month.
